Exhibitors - \$100 non-electric or \$135 limited electrical service for each space.
Food Vendors - \$150 per space which includes limited electrical service, if necessary.
Cancellation will result in loss of payment - no refunds.
2. Management **shall not be responsible** for any injury or loss. Exhibitor will be responsible for any damage or loss to the premises they occupy caused by their presence.
3. **Management will NOT provide insurance.** Insurance must be placed and paid for by exhibitor. Management is hereby relieved of all responsibility in connection with the safekeeping of vendors' property while at this event.
4. **The exhibitor agrees to display and/or sell** only those items that have been listed and agrees to remove any articles objectionable to management.
5. **This is an outdoor event** - vendors need to supply their own tent, tables, chairs, etc.
6. **No early tear downs.** Your booths must be manned at all times during the festival.
